SUB :: Report on unnatural death of Angad Sutradhar, Vill :: Pakriguri, Distt :: Baksa

Sir,

With reference to the above I have the honour to inform you that an enquiry was conducted in to the alleged suicidal death of one Angad Sutradhar of Village :: Pakriguri, PS :: Salbari, Sub Division :: Salbari, Dist :: Baksa through Shri Ananda Kumar Das, ACS, Sub Divisional Magistrate, Salbari. The Superintendent of Police, Baksa was also asked to submit a Police report on the issue.

As per the reports received, on 09/07/2015 Shri Jyotish Sutradhar, S/o :: Late Angad Sutradhar of Village Pakriguri, PS :: Salbari, Dist :: Baksa (Assam) lodged an FIR to the effect that on 08/07/2015 at about 10.30 pm his father Angad Sutradhar committed suicide by hanging on a tree. On receiving the FIR, a UD case was registered (No 04/15 of Salbari PS) at the Salbari Police Station and investigation started. Shri Ananda Kumar Das, ACS, Sub Divisional Magistrate, Salbari on receipt of information visited the spot and found the dead body of Angad Sutradhar hanging on a tree in the premises of his house. Accordingly, after observing all necessary formalities, the dead body was recovered, identified and subsequently sent for Post Mortem. After the completion of Post Mortem, the dead body of Angad Sutradhar was handed over to the family for disposal.

As per instruction of the undersigned on 10/07/2015, Shri Ananda Kumar Das, ACS, Sub Divisional Magistrate, Salbari visited village Pakriguri to enquire regarding the un-natural death of Angad Sutradhar. During the course of investigation, it was learnt from the family member as well as neighbours, that on 08/07/2015, Jyotish Sutradhar, S/o the deceased Angad Sutradhar went to the concerned NRC Seva Kendra (NSK) for submission of NRC Forms pertaining to his family. But he could not submit the same due to non-availability of linkage certificate of himself with his great-grandfather (ie Kalamoni) although legacy document of his paternal uncle
