Madam,

With reference to the above, I have the honour to inform you that, I have visited Upper Dumdumia GP office on 29/06/2015 and enquired in to the report published Asomiya Khabar news paper on 9<sup>th</sup> June 2015. During enquiry the following facts has been noted:

1. No employee of Dumdumia Gaonpanchayat office have collected money from public for issuing marriage certificate against any applicant. Though a few persons have claimed that Sh. Manas Pratim Saikia, AA of panchayat office has taken money, but no one present among the public have claimed that he or she has given money directly. So the charges of taking money for issue of certificate cannot be established.
2. The incident of public being aggravated and closing down the GP office happened on 9/6/2015 following irregular attendance of office by the GP secretary Sh. Montu Bora. Sh. Bora could not attend GP office regularly as he has been engaged as LRCR of Rampursatra NSK. The matter was immediately reported by secretary on the same day and OC, Batadrava PS was asked to provide necessary security at GP office in this regard. (copy enclosed)
3. It was a misunderstanding among the public as they thought that, the secretary of the GP office have intentionally not attend office to collect money by delaying the process of issuing marriage certificate.
