

Last date for submission of Additional Documents & Family Tree Forms to NRC Verification Teams/NSKs extended up to 31st March, 2016



No documents shall be received thereafter

Eligibility of the applicants for inclusion or exclusion into NRC shall be decided based on whatever documents have been submitted up to 31st March, 2016

Additional document is required to be submitted by applicants for reasons given below:

- If any applicant could not submit required documents during Form submission for any reason.
- If any applicant has mistakenly submitted Legacy Data of any other person having similar name with applicant's legacy person, then the applicant may submit correct Legacy Data Slip as additional document.
- If any applicant wants to submit any document in addition to those submitted with Application Form to strengthen their claim for inclusion in NRC.
- If any applicant has submitted illegible/not readable document, the Verification Team may ask for a clearer copy of the document for taking decision on its acceptability.
- If any applicant has submitted insufficient documents to prove eligibility for inclusion in NRC the Verification Teams may ask for additional documents to substantiate claim for inclusion in NRC.

Points to be noted about Family Tree Form submission:

- Family tree is the detail of different generations of a family comprising the names of ones ancestors, parents, uncles and aunts, siblings and cousins.
- Family Tree Forms have been collected by Verification Teams during their house to house visits undertaken for conducting verification. If any family has not yet submitted the Family Tree Form to the Verification Teams, it is requested to submit the Family Tree Form immediately at the designated NSK.
- Designated NSK is the one where an applicant has submitted the NRC Application Form. In case of online applicants, they can find the designated NSK from our website (Go to "Know your NSK" in the Home page).
- It may be noted that there is no facility for online submission of Family Tree Forms. Family Tree Details should be submitted only to Verification Teams during house to house visit or at designated NSKs.
- Public may obtain a blank copy of Family Tree Form from any NSK or can also download it from our website.

Additional documents & Family Tree Forms should be submitted on or before 31st March 2016 to members of Verification Teams or at designated NSK of the applicant

Attention is also invited from the online applicants about the "KNOW YOUR APPLICATION RECEIPT NUMBER (ARN)" facility

In case, if any applicant has misplaced or lost his/her Application Receipt Number (ARN) issued against the Online Application Form, he/she can call us at our toll free Helpline Number **15107** (within Assam) or call at **18003453762** (from outside Assam) to know the ARN. The applicant is required to provide any one of the following details:-

The name of the Head of the Family

OR

The phone number registered during the time of submission of the online Application Form

We are committed to conduct a completely unbiased verification process and come up with an error free NRC.

Family Tree Forms, therefore, shall be required from all applicants.

It is reiterated that the updated NRC will not include name of any foreigner and shall not exclude the name of any genuine Indian citizen.
