UPON hearing the counsel the Court made the following
O R D E R

We have considered the report of the Court Appointed Commissioner dated 4th October, 2015 filed pursuant to the order of this Court dated 14th July, 2015. Having perused the contents of the said report, we are of the view that the facts and findings mentioned therein should be responded to by the Union of India as well as the State of Assam. The response to the aforesaid report dated 4th October, 2015 including earlier two reports dated 5th June, 2015 and 29th June, 2015 be filed by the Union of India and the State of Assam within four weeks from today.

We have considered the report dated 5th October, 2015 filed by Shri Prateek Hajela, State Coordinator, NRC, Assam in compliance of the order of this Court dated 21st July, 2015, inter alia, seeking extension of time for publication of the draft NRC on 1st January, 2016. The learned State Coordinator has also stated before us that though it is not mentioned in the said report, the date of publication of final NRC may be fixed by the Court on 1st March, 2016.

Having considered all that has been stated in the aforesaid report dated 5th October, 2015 and the details of the process of verification undertaken, we are of the view that at this stage the date for publication of draft NRC should be fixed as 1st January, 2016 instead of 1st October, 2015. The process of verification including the field verification may be continued. Adequate manpower and NRC Kendras to deal with the process of verification including field staff as may be required may be engaged by the learned State Coordinator. In this regard, all assistance will be offered by the State of Assam by making available the requisite and adequate number of employees working at different levels in the State Government. We also direct the learned State Coordinator to file a report with regard

to the progress and result of the verification till date which would be considered by this Court on 5th November, 2015 at 3.00 p.m.

We request the Hon'ble the Chief Justice of India to make available this Bench on the said date i.e. 5th November, 2015 at 3.00 p.m.
