UPON hearing counsel the Court made the following

ORDER

Application for intervention is allowed.

- Heard Mr. Rakesh K. Khanna, learned Additional
 Solicitor General appearing for Union of India and Mr. Jaideep
 Gupta, learned senior counsel appearing for the State of Assam.
- 3. Apropos the order that this Court had passed on the last date of hearing Mr. Khanna points out that the Central

Government needs further time to make a positive statement whether the Central Government is accepting the Modalities as recommended by the State of Assam in making entries on the National Register of Citizens.

4. In our view it is high time that the Central

Government finalize the modalities as early as possible. The

Government of Assam has forwarded his proposal wayback in January

2013 though they have

suggested some modifications thereafter from time to time. The Central Government has not reacted through any communication to the State of Assam so far though meetings have been held between them. Now, we are assured that necessary meetings between the State Government and the Central Government will culminate into some accepted Modalities which Mr. Khanna states will require atleast three weeks. In the circumstances, on his request, we adjourn the present proceedings to 23rd August, 2013 to be notified at 2.00 p.m.

5. Mr. Jaideep Gupta has handed over to us a letter dated 2nd August, 2013 which was addressed by the Joint Secretary, Government of Assam,, Home and Political Department to Joint Secretary (North East) Government of India, Ministry of Home affairs, New Delhi. A tentative assessment of timeline is

enclosed with this letter. We find that this timeline means

quite a long period. Out of the six stages which have been

mentioned in this tentative assessment, first two stages are

essential in the nature of office work. The field work actually

starts from the stage three onwards. This being so, we would

like to say that State of Assam as well as the Central Government

should compress the first two stages and, if possible, complete

them within

six months. This would also be along with the stage of training

and preparing the personnel for this work as pointed out by Mr.

Jaideep Gupta. As far as stages No.3 onwards are concerned, we

would like to say that both the Governments should see that the

time period is compressed and the exercises proposed are

completed as early as possible.
